**Contract Live Foal Guarantee:** This is a live foal contract on the following basis:

- a) A live foal is one that stands and nurses within 4 to 8 hrs of foaling.
- b) An appropriate nutrition program as well as a mineral supplement, including all shots recommended by your veterinarian must be adhered to throughout gestation.
- c) Mare must be at an appropriate body condition score throughout gestation and there must be due care taken at time of foaling.
- d) In the event of a dead foal, notification must be given within 24 hours and a veterinary certificate must be issued and forwarded to Elysian Farm when available.
- e) Once the above criteria are met, a return breeding will be given; this return must be used within 2 breeding seasons.
- f) Should the Stallion die, sell, or become unfit for breeding, then the mare owner may use one of the other stallions who stand at Elysian Farm. If the mare owner chooses not to use one of the other stallions, then this contract is null and void.
- g) If the above-named mare dies or becomes unfit to carry a foal to term, during the breeding season then the Mare Owner may substitute another mare that is agreed to by both the Mare Owner and Stallion Owner.

**Mare Care – on site:**

- a) Mare must be up to date on shots – Flu, Rhino, West Nile, Tetanus, EEE and WEE. A current **Coggins Test** required, can be drawn upon arrival at Elysian Farm.
- b) If a veterinarian or farrier is required for mare or foal, these services will be at the mare owner's expense. Note in the event of an emergency we will attempt to contact the mare owner first, signing of this contract gives Elysian Farm authority to contact Alberta Veterinary Center in an emergency and follow their advice.
- c) Mare care is as follows:
  - i. Outdoor dry, small group \$18 per day to a maximum of \$550 per month
  - ii. Outdoor wet/individual \$25 per day to a maximum of \$650 per month if available.
  - iii. Indoor board, individual turnout/hotwalker \$35 per day to a max of \$900 per month

**Other**

Elysian Farm requires **24 Hours advanced notice via text 403-358-0487** for shipping semen, please inform us when your mare starts her heat cycle that you are wishing to breed on so that you can be penciled in for semen. All shipping and courier fees are the responsibility of the mare owner, please ensure that you have either a couriers account # or your CC on file for all shipping charges. Semen will not be shipped without. Please text 403-358-0487 when you are wishing to bring your mare or pick her up so that we can ensure that an employee is available to assist you.

Waiver of Liability: It is understood that Elysian Farm, its owners, employees, veterinarians, and guests shall not be liable for any injury, escape, disability, or death of any horse on its premises. The mare owner's signature on this contract attests to the fact that the owner has read and understood all the terms outline herein and accepts this contract as legal and binding. This contract constitutes the entire agreement between the parties. No other agreements, whether verbal or implied are included. This contract is made and entered into, in the province of Alberta, regardless of the manner of solicitation, and shall be interpreted, enforced, and transacted within said province under the laws of the Province of Alberta and the Country of Canada.
